 - If the candidate fails to furnish the proof of the stipulated minimum qualifications.
 - If any document(s) submitted by the candidate to the college is found to be forged, fabricated or false, during the period of study.
 - If the attendance is not as per the required norms, the admission may be cancelled immediately and the fee shall be forfeited.
 - If the candidate is found to have violated the rules & regulations of the college, in any way or manner.
- Right of Alteration/Modification:**
 - The college reserves its right to change the Fee Structure.
